#### ORDER:-

In the G.O. 1st read above, Government declared that the castes and communities specified in the Annexure–1 to that G.O. are socially and educationally backward and classified them into five Groups as 'A', 'B', 'C', 'D' and 'E'. The caste "Dommara" is included at Sl.No.7 under Group-'A' of State list and at Sl.No.7 of the common list of Other Backward Classes in the Central list.

- 2. It has been brought to the notice of the Government that some people are using abusive words like 'Dommara Nakodaka', 'Dommaroda', 'Dommarodila Unnavu', and also using proverbs against their community in public places and even in films also. These words are hurting the sentiments and degrading the self respect of the people belonging to their caste / community.
- 3. After careful consideration of the matter and in supersession of the orders issued in the references 2<sup>nd</sup> and 3<sup>rd</sup> read above, Government have decided to change their caste name from 'Dommara' to 'Dora Vamsa (Dommara)' at SI.No.7 under Group-'A' of State list to wipe out the mental agony of the caste people and to end the social humiliation on them. The Government accordingly issue the following amendment to G.O.Ms.No.1793, Education Department, Dt.23.09.1970:-

# **AMENDMENT**

The following shall be inserted as against at Sl.No.7 under Group 'A' to Annexure - I to G.O.Ms.No.1793, Education Department, Dt.23.09.1970 and read as follows:

### SL.No.7, Dora Vamsa (Dommara)

**Note:** The name "Dommara" noted in the bracket is only for the purpose of identification. The Caste / Community Certificates are required to be issued as "Dora Vamsa" only.
